# 2018 Interstate Wine Fest

## Participating Brewery/Distillery Terms and Conditions

1. The sponsors and/or event management company reserve the right to accept or reject each application. This event has no affiliation with The Maryland Wineries Association, Maryland Distillers Guild, or any entity other than **Interstate Festival Group, LLC**, Mountain Maryland Events, LLC, Girls Incorporated of Washington County, MD, the Washington County Board of County Commissioners and the Agricultural Education Center, and event sponsors.
2. Distillery Vendors are expected to provide liquor samples (1/4 ounce straight or mixed) free or at \$1 per sample, booth signage, literature, staff and unlimited volunteers, and any other equipment needed. Brewery Vendors are expected to provide beer samples (1-2 ounces) free, booth signage, literature, staff and unlimited volunteers, and any other equipment needed.
3. Brewery/Distillery Vendors may sell a mixed liquor cocktail/full pour beer by the glass (on site consumption only) and by the bottle/cans (for off sale consumption – a Wine Check service will be provided) and will keep 100% of their sales. Brewery/Distillery intentions for sampling vs. sales (including line formation and sales prices) must be clearly visible to the patrons via signage.
4. **Distillery Vendors must advise the state of Maryland their intent to participate in this event approved through Liquor Festival Permit Number LF-72270. Breweries will be provided a copy of our county liquor license and must use their off site permit.**
5. All participants must operate on Saturday, June 9, 2018 from 11am-6pm.
6. Other than what is included, no tents, tables or chairs will be provided. Please bring your own. Vendors, if not already reserved, may request these items, but they will not be guaranteed if not reserved. Up to four standard 10'X10' canopy tents will fit in the space under the structure provided, but will need sufficient leg weights as the ground is all concrete.
7. Brewery/Distillery staff and volunteers will have a special parking area and will gain free access to the event as "Vendors". Distillery staff and volunteers over 21 will receive free sampling glasses and wristbands, however a list of names must be submitted in advance.
8. **Application deadline is April 9, 2018. However, we will cap distilleries at SIX and Breweries at SIX.**
9. All accepted applicants will be notified via the mail and/or email. We will send detailed festival information, including attendance projections (avg. is 2,300), to participants as they are accepted and every two weeks leading up to the event. Your physical festival location information will be sent 30 to 45 days prior to the festival. If there are any special requests, please submit before this time. A comprehensive Vendor Manual will be sent 30 days prior to the festival.
10. THE FESTIVAL WILL GO ON RAIN OR SHINE. If not already covered, all vendors should have a substantial canopy or other protection for themselves.
11. Each vendor will be responsible for his/her property. Interstate Festival Group, LLC and its staff and underwriters are not responsible for any damage, theft, injury, or loss for any reason.
12. Security will be provided by event staff. Security will be on-site during the festival, including up to two hours before and after the scheduled event times.
