### Participating Winery/Distillery Terms and Conditions

1. The sponsors and/or event management company reserve the right to accept or reject each application. This event has no affiliation with The Maryland Wineries Association or any entity other than Interstate Festival Group, LLC, Mountain Maryland Events, LLC, Girls Incorporated of Washington County, MD, the Washington County Board of County Commissioners and the Agricultural Education Center, and event sponsors.
2. Wine Vendors are expected to provide wine samples (between ½ ounce and 1 ounce each), Distillery Vendors are expected to provide liquor samples (1/4 ounce straight or mixed). ALL vendors provide booth signage, literature, staff and unlimited volunteers, and any other equipment needed. \$1 samples of select premium products is permitted.
3. Wine Vendors may sell wine by the glass, Distilleries a mixed liquor cocktail (on site consumption only) and any by the bottle (for on and off sale consumption – a “Wine Check” service will be provided) and all will keep 100% of their sales. Winery/Distillery intentions for sampling vs. sales (including line formation and sales prices) must be clearly visible to the patrons via signage.
4. Wine/Distillery Vendors must advise the state of Maryland their intent to participate in this event approved via Wine Festival Permit and/or our County Liquor License.
5. Participants must operate on Saturday, June 13, 2020 from 11am-6pm (Friday is optional, but must be selected on application, Friday hours are 4pm-10pm).
6. Other than what is included, no tents, tables or chairs will be provided. Please bring your own. Vendors, if not already reserved, may request these items, but they will not be guaranteed if not reserved. Up to four standard 10’X10’ canopy tents will fit in the space under the structure provided, but will need sufficient leg weights as the ground is all concrete.
7. Winery/Distillery staff and volunteers will have a special parking area and will gain free access to the event as “Vendors”. Winery/Distillery staff and volunteers over 21 will receive free sampling glasses and wristbands at WILL CALL, each member must present ID.
8. Application deadline is April 10, 2020. However, we will cap wineries at 15 and Distilleries at 7.
9. All accepted applicants will be notified via email. We will send detailed festival information, including attendance projections (avg. is 2,200 Saturday, Friday will be around 1,000), to participants as accepted and leading up to the event. Your physical location information will be sent 30 to 45 days prior to the festival. If there are any special requests, please submit before this time. A comprehensive Vendor Manual will be sent 30 days prior to the festival.
10. THE FESTIVAL WILL GO ON RAIN OR SHINE. If not already covered, all vendors should have a substantial canopy or other protection for themselves.
11. Each vendor will be responsible for his/her property. Interstate Festival Group, LLC and its staff and underwriters are not responsible for any damage, theft, injury, or loss for any reason.
12. Security will be provided by event staff. Security will be on-site during the festival, including up to two hours before and after the scheduled event times only.
